

Information on your personal data

Dear Customer,

In view of our cooperation so far, and with respect to your rights, as provided for in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (referred to as “GDPR” or “General Data Protection Regulation”):

To whom may your data be provided?

In accordance with the applicable laws, we may provide your data to data processors who perform processing upon our instructions, e.g. suppliers of IT systems and services, marketing agencies, our subcontractors and entities entitled to obtain data in accordance with the applicable laws, e.g. courts and law enforcement authorities, only upon request submitted on an appropriate legal basis.

What are your rights with respect to your data?

You have the right to demand access to your data, their rectification, removal or restriction of processing. You may also withdraw consent to personal data processing, raise an objection, and use any other rights as provided for in GDPR. Any such requests should be delivered directly to the address listed above.

What are the legal bases for the processing of your data?

Your personal data will be processed solely for the purposes:

- connected with the performance of the Agreement, or taking necessary actions prior to the execution of the Agreement, (your data will not be stored for a period longer than necessary, i.e. for 62 months following the expiry of the Agreement).
- of performance of marketing activities.

The processing of your data must always be performed based on an appropriate legal basis, compliant with applicable laws. The legal basis for the processing of your data for the purposes of service provision is the necessity of the processing for the performance of the agreements on service provision (such agreements usually consist of the regulations or similar documents available with respect to the services you use). The processing of your data for marketing purposes will be carried out on the basis of your consent, to be provided by ticking the “**I agree**” box at the end of this document. The data controller does not intend to provide your data to any third parties or transnational organisations.
